## SIPO's Latest Official Fees of Patent Is

### Formally Effective on July 1, 2017 (List Attached)

SIPO's latest official fees of patent is formally effective on July 1, 2017. Compared with the former standard of patent official fees, there are five changes involved :

#### **Official Fees of Patent - Domestic Part (RMB)**

1. Clearly list out "Printing Fee for Notice 50 RMB" ;
2. Add "Production Fee for Patent Duplicate Copy or Certificate (Per Copy) 30 RMB". There are four types of patent duplicate copy and six types of certificate;

#### **PCT Application Entering into International Phase**

3. Clearly list out "Request for Recovering Right 1000 RMB";

#### **PCT Application Entering into National Phase in China**

4. Cancel "Request for Correcting Priority Claim 300 RMB";
5. Clearly list out "Priority Recover Fee 1000 RMB".
