CNIPA Issues Judgment Standards for General Trademark Violations: to be implemented from January 1, 2022

On December 16, 2021, the China National Intellectual Property Administration ("CNIPA") issued the *Judgment Standards for General Trademark Violations* (the "*Standards*") for implementation from January 1, 2022.

Consisting of 35 articles, the Standards set forth detailed provisions on nine types of illegal behaviors that disrupt the order of trademark management as identified in the existing laws, regulations and departmental rules, namely,

- (1) failure to use a registered trademark when it must be used;
- (2)use of any mark that cannot be used as trademark;
- (3)use of the words "well-known trademark" in a commercial activity;
- (4)trademark licensee's failure to indicate its name and the origin of goods as required by law;
- (5) change of the registered trademark, registrant's name, and address or other registration items without permission;

Trademarks

- (6)use of an unregistered trademark as a registered one;
- (7) failure to perform management obligations in collective trademark and certification trademark;
- (8) failure to perform trademark printing management obligations; and
- (9)malicious application for trademark registration.

Intellectual Property

China's IP Royalties Import and Export Volume Approach 280 Billion RMB in the First Three Quarters of 2021

According to CNIPA, in the first three quarters of 2021, China's IP royalties import and export volume approached 280 billion RMB, among which the export volume increased at a significant growth rate of over 27%, showing a great rise in the value and international competitiveness of China's IP rights.

Presently China's ranking in the 2021 GII Report published by the WIPO months ago has risen up to the twelfth, reaching another record-high in the GII Report. Staying top 1 among the middle-income economies, China is one of the fastest progressing countries around the world.

Moreover, from January to October 2021, the total amount of registered patent and trademark pledge financing reached 240.77 billion RMB. Achieving a growth rate of 50.6% with respect to the same period of 2020, said amount already exceeded the total amount for the whole year of 2020.
